The information requested includes amount of Direct Written Premiums and Direct Losses Paid for the following lines:

- 1 - Fire
- 2.1 - Allied Lines
- 2.5 - Private Flood
- 3 - Farmowners multi-peril
- 4 - Homeowners multi-peril

## Important Update: New Submission Process

This year, TICO is introducing a **new online portal** to streamline the submission process. Please review the key dates and reporting instructions below:

### Key Dates:

- **User Registration Begins:** January 15, 2025
- **Page 14 Submission Portal Opens:** March 1, 2025
- **Page 14 Submission Deadline (Portal Closes):** March 15, 2025

### Reporting Instructions:

1. **User Registration** Please use the below link to register a new user account on our portal by February 15, 2025.

2. **Report** Submission - Once you successfully complete the user registration process:
  - Instructions on how to submit the reports will be sent to all registered users by March 1.
  - Submission Portal will open to submit your completed report(s) starting March 1.
  - All submissions must be completed by March 15.

### Report Requirements:

- Line 1 (Fire) - please split the data by Dwelling, Farm & Ranch, and Other (Commercial).
- Line 2.1 (Allied Lines) - please split the data by Dwelling, Farm & Ranch, and Other (Commercial).

- For Line 2.5 (Private Flood) – please split the data by Dwelling, Excess, and Other (commercial).

Please note that TICO is the statistical agent for residential property, not commercial property, which is why this level of detail is required.
